### **INTERESTED PERSON APPLICATION FORM**

#### **GENERAL EXPLANATIONS**

Article 11 of the Law No. 6698 on the Protection of Personal Data ("KVKK" or "Law") regulates the rights of personal data owners or their legal representatives ("**Applicant**" or "**Relevant Person**"), who are defined as the relevant person within the scope of the Personal Data Protection Law No. 6698 ("KVKK" or "Law"), to make requests regarding the processing of personal data.

Pursuant to the first paragraph of Article 13 of the KVKK; applications to be made to **Limak Havacılık İletişim Eğitim ve Ticaret A.Ş. ("Limak Havacılık ")** , which is the data controller, regarding these rights must be submitted to us in writing or by other methods determined by the Personal Data Protection Board ("**Board**"). Depending **on its nature, your request will be answered as soon as possible or within thirty days at the latest from the date of receipt by Limak Havacılık** . However, if the transaction requires an additional cost, a fee may be charged in accordance with Article 7 of the Communiqué.

#### **APPLICATION METHOD**

- **Application by Mail or in Person:** Applicants may apply in person or by mail to Hafta Sokak No: 9 Gaziosmanpaşa ÇANKAYA/Ankara with the application form filled out and signed by the Applicant and documents certifying their identity.
- **Application via Registered Electronic Mail (KEP):** The application form can be signed by the applicant with the "secure electronic signature" defined in the Electronic Signature Law No. 5070 and sent to [limakhavacilik@hs02.kep.tr](mailto:limakhavacilik@hs02.kep.tr) .
- **Application via Electronic Mail using Mobile Signature or Secure Electronic Signature:** An application can be made by sending an e-mail to [kvkk\\_havacilik@limak.com.tr](mailto:kvkk_havacilik@limak.com.tr) by filling out a petition signed by the Applicant with a mobile signature or secure electronic signature, or by filling out the "Application Form".

In order for your application to be concluded quickly, it is recommended to indicate on the application envelope or in the subject section of the e-mail that it is "**Personal Data Protection Law Information / Amendment Request**".

Applications can also be made through a Notary Public or other legally valid means of verifying identity. It is recommended to comply with the above-mentioned points in the applications to the extent possible, as this will increase the likelihood of the application being concluded positively and in a short time.
